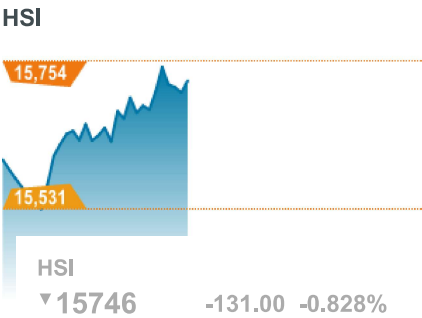

The Hong Kong Investment Funds Association (HKIFA) recently voiced its full support for the consultation paper on market opening in adverse weather, citing that the issuers and related managers of European exchange-traded funds (ETFs) were affected by the closure of Hong Kong's market due to adverse weather.

Mofiz Chan, chairman of Hong Kong Securities and Futures Professionals Association (HKSFPA), yet refuted that there are only about 2.2 days of market closure due to inclement weather in Hong Kong each year, while there are differences in the arrangements for public holidays in Europe and Asia.

He added that the stance of HKIFA's Chief Executive Officer, Sally Wong, who is also a member of the Task Force on Enhancing Stock Market Liquidity, may be biased.
